## **Statement of intent**

**Discovery Schools Academies Trust** , further referred to as **Discovery** or **the organisation** is committed to maintaining the confidentiality of its information and ensuring that all records within the organisation are only accessible by the appropriate individuals. In line with the requirements of the General Data Protection Regulation (GDPR), DSAT also has a responsibility to ensure that all records are only kept for as long as is necessary to fulfil the purpose(s) for which they were intended.

DSAT has created this policy as part of the Data Protection Strategy to outline how records are stored, accessed, monitored, retained and disposed of, in order to meet the Organisations statutory requirements.

This document complies with the requirements set out in the GDPR and UK Data Protection Act (2018)

## 1. Legal framework

- 1.1. This policy has due regard to legislation including, but not limited to, the following:
  - General Data Protection Regulation (2016)
  - Freedom of Information Act 2000
  - Limitation Act 1980 (as amended by the Limitation Amendment Act 1980)
- 1.2. This policy also has due regard to the following guidance:
  - Information Records Management Society 'Information Management Toolkit for Schools' 2016
- 1.3. This policy will be implemented in accordance with the Data Protection Strategy and following trust policies and procedures:
  - **ICT Acceptable Use Policy**
  - **Data Security Incident Management Policy**
  - **Freedom of Information Policy**
  - **CCTV Policy**
  - **School Workforce Privacy Notice**
  - **Parent/carer Privacy Notice**
  - **Governor Privacy Notice**

## 2. Responsibilities

- 2.1. DSAT has a responsibility for maintaining its records and record-keeping systems in line with statutory requirements.
- 2.2. The **CEO** holds overall responsibility for this policy and for ensuring it is implemented correctly.
- 2.3. The **DPO** is responsible for the management of records at **Discovery Schools Academies Trust** and **Local Data Protection Representatives** are responsible for the management of records in schools.
- 2.4. The **DPO** is responsible for promoting compliance with this policy and reviewing the policy on an **annual** basis, in conjunction with the **trust executive team**.
- 2.5. The **DPO** is responsible via carrying out termly audits, for ensuring that all records are stored securely, in accordance with the retention periods outlined in this policy and are disposed of correctly.
- 2.6. All staff members are responsible for ensuring that any records for which they are responsible for are accurate, maintained securely and disposed of correctly, in line with the provisions of this policy.

## 3. Management of pupil records

- 3.1. Pupil records are specific documents that are used throughout a pupil's time in the education system – they are passed to each school that a pupil attends and includes all personal information relating to them, e.g. date of birth, home address, as well as their progress and achievement.

- 3.2. The following information is stored on the front of a pupil record file , and will be easily accessible:
- Forename, surname, gender and date of birth
  - Unique pupil number - UPN
  - Note of the date when the file was opened
  - Note of the date when the file was closed, if appropriate
- 3.3. The following information is stored **inside the front cover** of a pupil record, and will be easily accessible. Where possible use your MIS to manage this data but use the inside cover for staff who don't have appropriate access to the MIS.
- Ethnic origin, religion and first language (if not English)
  - Any preferred names
  - Position in their family, e.g. eldest sibling
  - Emergency contact details and the name of the pupil's doctor
  - Any allergies or other medical conditions that are important to be aware of
  - Names of parents, including their home address(es) and telephone number(s)
  - Name of the school, admission number, the date of admission and the date of leaving, where appropriate
  - Any other agency involvement, e.g. speech and language therapist.
- 3.4. The following information is stored in a pupil record, and will be easily accessible:
- Admissions form
  - Details of any SEND
  - If the pupil has attended an early years setting, the record of transfer
  - Privacy Notice – only the most recent notice will be included
  - Annual written reports to parents
  - Hard copy notes relating to major incidents and accidents involving the pupil
  - Any information about an education and healthcare (EHC) plan and support offered in relation to the EHC plan
  - Any information relating to exclusions (fixed or permanent)secondary
  - Any correspondence with parents or external agencies relating to major issues, e.g. mental health
  - Notes indicating that records of complaints made by parents or the pupil are held
- 3.5. The following information is subject to shorter retention periods and, therefore, will be stored separately in a personal file for the pupil in the **school office**:
- Absence notes

- Parental and, where appropriate, pupil consent forms for educational visits, photographs and videos, etc.
  - Correspondence with parents about minor issues, e.g. behaviour
- 3.6. Hard copies of disclosures and reports relating to child protection are stored in a sealed envelope, in a securely locked filing cabinet in the [head teachers](#) office - a note indicating this, is marked on the pupil's file.
  - 3.7. Actual copies of disclosures and reports are stored separately on the school's CPoms systems and held in line with the retention periods outlined in this policy – a note indicating this, is marked on the pupil's file. An additional copy may be placed in the pupil's file in the event of a major accident or incident.
  - 3.8. Hard copies of complaints made by parents or pupils are stored in a secure file in the [school office](#) – a note indicating this, is marked on the pupil's file.
  - 3.9. Actual copies of accident and incident information are stored separately on the school's management information system and held in line with the retention periods outlined in this policy – a note indicating this is marked on the pupil's file. An additional copy may be placed in the pupil's file in the event of a major accident or incident.
  - 3.10. The school will ensure that no pupil records are altered or amended before transferring them to the next school that the pupil will attend.
  - 3.11. The only exception to the above is if any records placed on the pupil's file have a shorter retention period and may need to be removed. In such cases, [the Local Data Protection Representative](#) (LDPR) responsible for disposing records, will remove these records.
  - 3.12. Electronic records relating to a pupil's record will also be transferred to the pupils' next school.
  - 3.13. The school will, wherever possible, avoid sending a pupil record by post. Where a pupil record must be sent by post, it will be sent by registered post, with an accompanying list of the files included. The school it is sent to is required to sign a copy of the list to indicate that they have received the files and return this to the school.

## 12. Storing and protecting information

- 12.1. The **Director of Operations** will undertake a risk analysis to identify which records are vital to school management and these records will be stored in the most secure manner.
- 12.2. The **IT team** will conduct a back-up of digital information on a regular basis to ensure that all data can still be accessed in the event of a security breach, e.g. a virus, and prevent any loss or theft of data.
- 12.3. Where possible, backed-up information will be stored off the school premises, using a central back-up service operated by the Trust.
- 12.4. Confidential paper records are kept in a locked filing cabinet, drawer or safe, with restricted access.
- 12.5. Confidential paper records are not left unattended or in clear view when held in a location with general access.
- 12.6. Digital data is coded, encrypted and/or password-protected, both on a local hard drive and on a network drive that is regularly backed up securely either on site or off-site.
- 12.7. Where data is saved on removable storage or a portable device, the device is kept in a locked and fireproof filing cabinet, drawer or safe when not in use.
- 12.8. Pen Drive (memory sticks) will not be used to hold personal information unless they are password-protected and fully encrypted
- 12.9. All electronic devices are password-protected to protect the information on the device in case of theft.
- 12.10. Where possible, Discovery enables electronic devices to allow the remote blocking or deletion of data in case of theft.
- 12.11. Staff and governors do not use their personal laptops or computers for school purposes.
- 12.12. All members of staff are provided with their own secure login and password, and every computer regularly prompts users to change their password.
- 12.13. Emails containing sensitive or confidential information are password-protected to ensure that only the recipient is able to access the information. The password will be shared with the recipient in a separate email.
- 12.14. Circular emails to parents are used they are sent blind carbon copy (bcc), so email addresses are not disclosed to other recipients OR 3<sup>rd</sup> party communication providers are used.
- 12.15. In the infrequent case of sending confidential information by fax, staff will always check that the recipient details are correct and that they are aware of incoming communication before it is sent.
- 12.16. Where personal information that could be considered private or confidential is taken off the premises, to fulfil the purpose of the data in line with the GDPR, either in an electronic or paper format, staff take extra care to follow the same procedures for security, e.g. keeping devices

under lock and key. The person taking the information from the school premises accepts full responsibility for the security of the data.

12.17. Before sharing data, staff always ensure that:

- They have consent from data subjects to share it.
- Adequate security is in place to protect it.
- The data recipient has been outlined in a privacy notice.

12.18. All staff members will implement a 'clear desk policy' to avoid unauthorised access to physical records containing sensitive or personal information. All confidential information will be stored in a securely locked filing cabinet, drawer or safe with restricted access.

12.19. Under no circumstances are visitors allowed access to confidential or personal information. Visitors to areas of the school containing sensitive information are supervised at all times.

12.20. The physical security of the school's buildings and storage systems, and access to them, is reviewed **termly** by the **site manager** in conjunction with **the Estates and Admissions Manager**. If an increased risk in vandalism, burglary or theft is identified, this will be reported to the **Executive Team** and extra measures to secure data storage will be put in place.

12.21. The school takes its duties under the GDPR seriously and any unauthorised disclosure may result in disciplinary action.

12.22. The DPO, **Director of Operations and the Director of IT are** responsible for continuity and recovery measures are in place to ensure the security of protected data.

12.23. Any damage to or theft of data will be managed in accordance with the school's **Data Security Incident Management Policy**

### 13. Accessing information

13.1. **Discovery Schools Academies Trust** is transparent with data subjects, the information we hold and how it can be accessed.

13.2. All members of staff, parents of registered pupils and other users of the school, e.g. visitors and third-party clubs, are entitled to:

- Know what information the school holds and processes about them or their child and why.
- Understand how to gain access to it.
- Understand how to provide and withdraw consent to information being held.
- Understand what the school is doing to comply with its obligations under the GDPR.

13.3. All members of staff, parents of registered pupils and other users of the school and its facilities have the right, under the GDPR, to access certain personal data being held about them or their child.

13.4. The trust/school will adhere to the provisions outlined in the trust's **GDPR Data Protection Strategy** when responding to requests seeking access to personal information.

## 14. Disaster Recovery Plan

- 14.1. Digital data that is retained for longer than six years will be covered in the **Disaster Recovery Plan (DRP)**.
- 14.2. The **Director of IT** will identify any digital data that will need to be named as part of a DRP.
- 14.3. The data will be archived to dedicated files on the school's server, which is password-protected – this will be backed-up in accordance with section 10 of this policy.
- 14.4. Memory sticks will never be used to store digital data, subject to a DRP.
- 14.5. The Director of IT will review new and existing storage methods annually and, where appropriate add them to DRP.
- 14.6. The following information will be included within the digital continuity statement:
  - A statement of purpose and requirements for keeping the records
  - The names of the individuals responsible for long term data preservation
  - A description of the information assets to be covered by the digital preservation statement
  - A description of when the record needs to be captured into the approved file formats
  - A description of the appropriate supported file formats for long-term preservation
  - A description of the retention of all software specification information and licence information
  - A description of how access to the information asset register is to be managed in accordance with the GDPR

## 15. Information audit

- 15.1. The trust and all schools in the multi academy group conduct information audits on an **annual** basis against all information held by the school to evaluate the information the school is holding, receiving and using, and to ensure that this is correctly managed in accordance with the GDPR. This includes the following information:
  - Paper documents and records
  - Electronic documents and records
  - Databases
  - Microfilm or microfiche
  - Sound recordings
  - Video and photographic records
  - Hybrid files, containing both paper and electronic information
- 15.2. The information audit may be completed in a number of ways, including, but not limited to:
  - Interviews with staff members with key responsibilities – to identify information and information flows, etc.
  - Questionnaires to key staff members to identify information and information flows, etc.
  - A mixture of the above

- 15.3. The **Local Data Protection Representative** is responsible for completing the information audit following trust guidelines. The information audit will include the following:
- The school's data needs
  - The information needed to meet those needs
  - The format in which data is stored
  - How long data needs to be kept for
  - Vital records status and any protective marking
  - Who is responsible for maintaining the original document
- 15.4. The **DPO** will carry out a quality assurance audit and consult with staff members involved in the information audit process to ensure that the information is accurate.
- 15.5. Once it has been confirmed that the information is accurate, **the Data Protection Officer** will record all details on the trust's **Information Asset Register, GDPR Sentry**.
- 15.6. The information displayed on **GDPR Sentry** will be shared with the **CEO** to gain their approval.

## **16. Disposal of data**

- 16.1. Where disposal of information is outlined as standard disposal, this will be recycled appropriate to the form of the information, e.g. paper recycling, electronic recycling.
- 16.2. Where disposal of information is outlined as secure disposal, this will be shredded and electronic information will be scrubbed clean and, where possible, cut. The **Local Data Protection Representative** will keep a record of all files that have been destroyed which will be countersigned by the **DPO** on a termly basis.
- 16.3. Where the disposal action is indicated as reviewed before it is disposed, the **DPO** will review the information against its administrative value – if the information should be kept for administrative value, the **DPO** will keep a record of this.
- 16.4. If, after the review, it is determined that the data should be disposed of, it will be destroyed in accordance with the disposal action outlined in this policy.
- 16.5. Where information has been kept for administrative purposes, the **DPO** will review the information again after **three** years and conduct the same process. If it needs to be destroyed, it will be destroyed in accordance with the disposal action outlined in this policy. If any information is kept, the information will be reviewed every **three** subsequent years.
- 16.6. Where information must be kept permanently, this information is exempt from the normal review procedures

## **17. Monitoring and review**

- 17.1. This policy will be reviewed on an **annual** basis by the **Executive Team** with guidance from the DPO – the next scheduled review date for this policy is **May 2024**.
- 17.2. Any changes made to this policy will be communicated to all members of staff and the governing board.
